

Albertsons/Tom Thumb/Randalls Alaskan Fishing Trip Sweepstakes 2020 Official Rules

NO PURCHASE NECESSARY TO ENTER OR TO WIN ALBERTSON/TOM THUMB / RANDALLS ALASKAN FISHING TRIP SWEEPSTAKES (THE "SWEEPSTAKES"). VOID WHERE PROHIBITED BY LAW.

1. **SWEEPSTAKES PERIOD:** The Alaskan Fishing Trip (the "Sweepstakes"), begins 12:00 AM (midnight) Central Standard Time ("CST") on March 4, 2020 and ends 11:59 PM CST on March 31, 2020 ("Sweepstakes Period").

2. **ELIGIBILITY:** This Sweepstakes is open to legal residents of Texas who are 18 years of age or older as of March 4, 2020. Then, during the Sweepstakes Period, to enter via one of the Websites or Mobile Apps, Clip the AHA (available March 4, 2020 through March 31, 2020) " Digital Coupon ("Offer") and redeem the offer within the eligibility period and you will automatically receive one (1) entry into the Sweepstakes. Offer may be redeemed once daily during the Sweepstakes Period.
